

## Helicopter Technology Company Limited Warranty for New Product

Helicopter Technology Company (HTC) warrants each Main Rotor Blade and/ or Tail Rotor Blade to the first End-User, to be free from defects in material or workmanship for a period of 12 months or 1,000 hours of operation, whichever comes first. Proof of purchase and proof of hours of operation must be provided when filing a claim.

HTC's obligation under this Limited Warranty is limited to the repair or replacement, which will be determined by HTC in its sole and absolute discretion.

Any Blades returned to HTC for Limited Warranty consideration must be shipped freight prepaid by the returning party. HTC will pay freight for the items returned to the customer.

This Limited Warranty shall not apply to any Main Rotor Blade and/or Tail Rotor Blade that has, in the exclusive judgment of HTC, been damaged, altered, or repaired outside the HTC factory, any of which shall render this Limited Warranty void.

This Limited Warranty shall not apply to any Main Rotor Blade and/or Tail Rotor Blade that has, in HTC's exclusive judgment, been subjected to other than normal and intended use and service, or any abuse, negligence, erosion, corrosion or accident.

After determining to its satisfaction that the Blade is defective and within the Limited Warranty period, HTC shall repair or replace the item at its sole discretion. The repaired or replacement Blade will then be warranted for the remainder of the original Limited Warranty period only.

**PROCEDURE:** The customer shall make a claim to HTC including the Aircraft Owner, Aircraft Registration, Part Number(s) of the affected HTC Products, Serial Number(s) of the affected HTC Products, and a detailed written description of the condition. The subject Main and/or Tail Rotor Blade(s) must be returned to the HTC facility at the address listed on our website at <a href="www.helicoptertech.com">www.helicoptertech.com</a> for HTC inspection. A written notice of a claim under this Limited Warranty must be given promptly to HTC, but in no event later than 30 days after the date of discovery.

This Limited Warranty is exclusive and is given and accepted in lieu of any other warrantees, express of implied, including any implied warranty of merchantability or fitness for a particular purpose. In addition this Limited Warranty is expressly in lieu of any non-contractual liability for property damage, including product liability. Customer's only remedy is provided by this Limited Warranty and is limited to the replacement or repair of the defective Main Rotor Blade and/or Tail Rotor Blade(s). Customer's rights with regard to personal injury are not affected by this provision.

In no event will HTC be liable for collateral or consequential damages or for any other costs. HTC does not authorize anyone to assume for it any other obligation, or liability on its behalf in connection with the sale of its Blade products, unless it is in writing and signed by an authorized representative of HTC.

This Limited Warranty shall apply only to the first End-User of a Main Rotor Blade and/or Tail Rotor Blade, and shall be Void upon the Sale or Transfer of Ownership of the Blade, the Helicopter to which it has been installed, or any change of ownership of the Original Customer.



## Helicopter Technology Company Limited Warranty for Repaired Product

Helicopter Technology Company (HTC) warrants each Repaired Rotor Blade and/ or Repaired Drive Shaft, to be free from defects in material for a period of 6 months or 300 hours of operation, whichever comes first and free from defects in workmanship for a period of 1 month or 100 hours of operation, whichever comes first. Proof of Hours of Operation must be provided when filing a claim.

HTC's obligation under this Limited Warranty is limited to the repair or replacement, which will be determined by HTC in its sole and absolute discretion.

Any Blades or Drive Shafts returned to HTC for Limited Warranty consideration must be shipped freight prepaid by the returning party. HTC will pay freight for the items returned to the customer.

This Limited Warranty shall not apply to any Rotor Blade and/or Drive Shaft that has, in the exclusive judgment of HTC, been damaged, altered, or repaired outside the HTC factory, any of which shall render this Limited Warranty void.

This Limited Warranty shall not apply to any Rotor Blade and/or Drive Shaft that has, in HTC's exclusive judgment, been subjected to other than normal and intended use and service, or any abuse, negligence, erosion, corrosion or accident.

After determining to its satisfaction that the Rotor Blade or Drive Shaft is defective and within the Limited Warranty period, HTC shall repair or replace the item at its sole discretion. The repaired or replacement Blade or Drive Shaft will then be warranted for the remainder of the original Limited Warranty period only.

**PROCEDURE:** The customer shall make a claim to HTC including the Aircraft Owner, Aircraft Registration, Part Number(s) of the affected HTC Products, Serial Number(s) of the affected HTC Products, and a detailed written description of the condition. The subject Rotor Blade and/or Drive Shaft(s) must be returned to the HTC facility at the address listed on our website at <a href="https://www.helicoptertech.com">www.helicoptertech.com</a> for HTC inspection. A written notice of a claim under this Limited Warranty must be given promptly to HTC, but in no event later than 30 days after the date of discovery.

Customer's rights with regard to personal injury are not affected by this provision.

HTC does not authorize anyone to assume for it any other obligation, or liability on its behalf in connection with the sale of its Blade products, unless it is in writing and signed by an authorized representative of HTC.

This Limited Warranty shall apply only to the first End-User of a Repaired Rotor Blade and/or Repaired Drive Shaft, and shall be Void upon the Sale or Transfer of Ownership of the Blade and/or Drive Shaft, the Helicopter to which it has been installed, or any change of ownership of the Original Customer.
